COURSE DESCRIPTION:

Students are introduced to the research paper and critical analysis. Students will learn research methods for conducting library and Internet research. Students will evaluate, paraphrase, summarize, quote, and integrate outside sources, and document and format papers using the MLA style manual.

OBJECTIVES:

The primary goal of the course is to help students learn how to think critically, write a literary analysis paper, write argument, conduct library research, and write a research paper using MLA style documentation. Students will become more familiar with the library's holdings and materials. Teaching methods will include examining research models and analyzing exemplary research papers. Students will learn to think critically and creatively through the process of interpreting, analyzing, and evaluating outside sources.

STUDENT LEARNING OUTCOMES:

At the end of EN 102 students will be able to:

1. Use electronic and print sources, including reference books, books, periodicals, and journals and library databases, other official
2. Use writing and reading for inquiry, learning, thinking, and communicating
3. Understand a researched writing assignment as a series of tasks, including finding, evaluating, analyzing, and synthesizing appropriate primary and secondary sources Integrate their own ideas with those of others
4. Adopt appropriate voice, tone, and level of formality
5. Write in several genres
6. Reflect on writing and learning processes
7. Practice appropriate means of documenting their work
8. Students can compose a range of formal and informal texts taking into consideration the interrelationships among form, audience, context, and purpose; students understand that writing is a recursive process
9. Students know the conventions of English language as they relate to various rhetorical situations (grammar, usage, and mechanics); they understand the concept of dialect and are familiar with relevant grammar systems

Course Outcomes: By the end of English 102, each student who earns a C or better will have...

1. Written major assignments in a minimum of three genres.
2. Produced a portfolio that includes revised and edited assignments totaling 3750-5000 words (approximately 15 double-spaced pages).
3. Written and revised multiple drafts of each major assignment to improve and/or clarify the writing project's purpose, thesis, organization, use of supporting details, use of source material, documentation, conventions, and audience awareness
4. Evidence of researching and evaluating a variety of outside sources.
5. Integrated outside sources into paper and cited all outside sources correctly and consistently using an accepted and current form of documentation such as MLA.
6. Worked effectively in peer groups to give and receive substantive feedback on drafts.
7. Reflected on writing process and growth in writer's memos for each draft and an opening statement in the final portfolio.

The Writing Center and My office hours:

Please stop by my office just to say hi and introduce yourself as soon as possible. I look forward to working with each of you and want to meet you on an "informal" or friendly basis.

Any visit to the Writing Center to work with me on a paper will remove one absence for the semester. If this is another English faculty besides me, that person who reads and responds to your essay must sign his/her name on your paper as indication of an at least 15 minute conference.

Class Attendance and Participation:

Students must bring the textbook to class every day. I would recommend that you get the book today and bring it to class on Wed. After 3 weeks of class you will not be admitted to class without a textbook.

I cannot stress enough the vital importance of attending this class every class period. Most of the work we do in this class will happen right in this classroom. Never miss a class period except for an emergency.

Attendance and participation count for 10% of your grade. You will receive a 10% "A" if you do not miss any class periods. You will receive and "F" if you miss more than six classes without an official university excuse. It is vital to be in attendance when class begins, which is when attendance is taken. A student with 3 "tardies" equals 1 unapproved absence. A student who leaves class and does not return for 15 minutes or more is considered "absent."

Students are allowed a maximum of six absences. A student with six or more unexcused absences fails the course. Do not take this class at this time if you have another obligation at this hour (i.e.: job, etc. When students must be absent from class, they are required to make up missed work on the day they return to class. When students know in advance that they will be absent from class, instructors must be notified and arrangements made to secure assignments ahead of time. The worst action a student can take is to miss class, not inform the instructor, and expect to be able to make-up class work when he/she returns to class without an excuse.

Note: I do not excuse absences. That is the job of the Office of Student Affairs. Students may obtain an official excuse from class due to an emergency (illness, accidents, jury duty, or death in the immediate family) or for attendance at officially – authorized functions and authorized field trips sponsored by the University. Official absences must be presented to the instructor within seven days from the date of the absence entitle the student to make up work missed. Athletes must also bring in excuses, since not all athletes travel.

CLASSROOM DEMEANOR:

Students are required to show respect to each other and to the professor at all times. The professor is in charge of the class at all times and must continue teaching the class. No shouting is allowed. If a student receives a grade that is upsetting they are required to be a young professional, and speak to the instructor in a calm and respectful tone. Good times for this are: during my office hours or before/after class. Disrespectful behavior prevents the instructor from teaching the class and will not be tolerated. Students who behave in a disrespectful manner to the instructor will be asked to leave class, so that the instructor can continue performing her required duties. The disruptive student will be marked absent for that class period.

PARTICIPATION:

Students must furthermore complete all work such as peer reviews, instructor conferences, class discussions, and group work. No late work will be accepted after 1 week. No student will receive a passing grade without having turned in each of the five major requirements (literary analysis, argument, annotated bibliography, research paper, remix) and the final portfolio including the final reflection letter.

Papers need to be turned in directly to me during class or during my office hours. Any work “on your flash drive” is work that is not done, and you will receive a zero for it. All papers must be printed on hard copy and due when each student arrives in the class. Plan ahead for deadlines.

Deadlines are final, so be sure to prepare for them and turn work in on time. No late papers will be accepted after the last day of class.

I expect each student to come prepared to participate actively in the day’s work. Thoughtful participation is especially important on draft workshop days. Class participation, as I see it, does not necessarily mean that a student is the life of the party. Instead, it includes helping yourself and others learn by asking questions.

Save Everything:

Keep copies of everything from the course—your drafts, memos, reflections, peer review sheets, everything! You will be asked to turn in graded papers again at the end of the semester in a final portfolio. Also, this evidence is the best way to protect you in the event of a clerical error on my part.

There is a **no cell phone policy** for this class. A student with a visible cell phone during the 50 minutes of class may receive a zero for class participation. The same applies for a phone that rings during the class period. Students may not leave the class to answer a phone call. If you have a family emergency you must tell me before the class begins, and I will allow you to have a phone on vibrate, and allow you to leave the room to take the call. This is the only exception.

Acceptable Draft Policy:

If a paper is unacceptable I will write “revise” or “R” at the top of the paper, and not give it a grade; this means the paper has not met key requirements of an assignment. If I return a draft to you marked unacceptable, see me immediately. You only have one week to resubmit it. NOTE: Because each formal assignment addresses different course objectives and outcomes, you must have an acceptable draft of each formal project to be eligible to pass the course.

Students you will also include a **writer’s memo**—a memo to readers in which the student writes *in detail* about what kinds of revisions you have made and why you made them. Because reflection on your writing is such an important part of this course, drafts submitted without a writer’s memo are also considered unacceptable.

Final Portfolio:

At the end of the semester, students will compile a **final portfolio of approximately 15 pages** that includes their best revised writing. This portfolio will have previously graded papers that have been revised A FINAL TIME. This final portfolio will also include a two-page FINAL REFLECTION/MEMO that analyzes the development of the student’s writing development throughout the course. The success of the portfolio will depend greatly on the quality of revisions you have made.

Cheating and Plagiarism Policy:

Plagiarism is the deliberate submission of someone else’s work as your own. Plagiarism and other forms of academic dishonesty (such as turning in a paper written for another class) will not be tolerated. Students will receive a grade of “0” for plagiarizing or cheating on any given assignment the first time it occurs. If this occurs a second time, the student will likely fail the course. Being rushed is never an excuse for plagiarism! Ask for more time if necessary, but better yet, plan ahead and give your written work the time and integrity it deserves.

Academic Integrity:

Academic integrity is a commitment to the values of honesty, trustworthiness, fairness, respect and responsibility in academia. Academic integrity is violated by any dishonest act that is committed in an academic context. Honesty and integrity are essential values of the Mississippi Valley State University’s mission to pursue truth and knowledge. Academic excellence can be reached only with the cooperation and support of students. Students are expected therefore to

accept responsibility for maintaining honesty and integrity in all acts inside and outside the classroom, studio, or laboratory.
