International Students – Fees	9/9/19	International students who have NOT been awarded institutional scholarships, have NOT made satisfactory payment arrangements with the Office of Student Accounts or have NOT notified the Office of Student Accounts of any third party payments (Ex. Department of Children Family Services, Embassy of Ghana) will be required to pay their academic year balance, in full before being issued an I-20. Please be reminded that international students are required to submit proof of sponsorship showing enough funds (in USD) to cover tuition, room and board, and personal funds to be admitted to Mississippi Valley State University. Students- Admissions		First year undergraduate applicants must have received a high school diploma with a B average or above, in laboratory science, social studies, and mathematics. A WES (World Education Services) course-by-course, evaluated transcript must be submitted for all first year and transfer, international students. You will find all the information you need at <u>www.wes.org</u> . Be sure to read and follow the "Required Documents" information specific to your country of study to ensure that your evaluation is completed as quickly as possible. Please ensure the Mississippi Valley State University is listed as the recipients of the WES evaluation. In addition, freshman applicants are required to submit either the American College Test (ACT) score of 21 or above or the Scholastic Aptitude Test (SAT) 1060-1090. Transfer applicants who have completed 12 or more hours of university-level academic courses with a B average will not be required to take the ACT or SAT and may be awarded transfer credit. The official I-20 document is issued after the student is fully accepted.

Transfer Applicants	3/15/20	 Transfer applicants are students who have attended another college. Any information withheld or falsified may subject a student to dismissal. In order to be admitted, the following REQUIREMENTS must be met: Submit official transcripts from all accredited colleges/universities attended Must be in "good academic standing" and eligible to return to the last college/university of attendance Regular transfer student status will be given to all transfer students with a 2.0 and above Grade Point Average. Mississippi Valley State University reserves the right to decline admission to any student with less than a 2.0 GPA. *Provisional status may be granted to transfer students prior to
		completion of the semester in which they are to enroll when applying. The deadline to submit the final official transcript will be the first day of class for the semester in which they are enrolled. Failure to submit the official transcript to the Office of Admission will result in removal of class registration.
